FACILITY FOR RESUBMISSION OF PROJECTS AND SPECIAL EXAMINATION (ODD-SEMESTER AND EVEN-SEMESTER COURSES)

As approved by the Vice-Chancellor, the students for the batches of 2013-2018, 2014-2019 and 2015-2020 who could not pass all the prescribed courses even after appearing for the End Semester and Repeat Examinations and who have completed all the five years of Programme of B.A. LL.B. (Hons) and B.Com. LL.B. (Hons) is being provided the facility for Re-submission of project for 30 Marks/Special Examination for 100 Marks.

A. Facility for Re-Submission of Project (30 Marks):

The facility for Re-Submission of Project can be availed only for those students who have arrears on the Odd and Even-Semester Courses despite appearing in the Odd-Semester, Jan-Feb, 2020 and Even-Semester, June, 2019. The component of Continuous/Internal Assessment (Odd & Even Semester Courses) comprises of Research Paper (20 Marks) and Viva-voce (10 Marks) (30 marks in all).

Fee:

The eligible students who opt for the facility of Resubmission of projects for 30 Marks are instructed to submit the filled in application along with fee payment of Rs.1,000/- per course through UCO Bank Challan of TNNLS Branch or a proof of the online-payment transaction to the Examination Section on or before 16th October 2020, before 5 p.m.

Research Paper submission:

The topic of the Research Paper will be approved by the course faculty concerned as per the Enclosure-1.

All the eligible students are instructed to submit their Research Paper to the faculty concerned on or before 6th November, 2020, before 5 p.m.

Note: All consultations/submissions with the course faculty concerned will be done via e-mail. Students will not be required to visit TNNLU campus in this regard.

Viva-voce:

Viva-voce for the Research paper will be conducted by the concerned course faculty members in the manner they deem fit (as per the Enclosure-1) on or before 09th November 2020.

B. Special Examinations (100 Marks – 3 Hours):

The facility of Special Examination for 100 marks can be availed only for those students who have arrears in not more than six courses (**Odd and Even-Semester Courses**). All the eligible students who opt for the facility of Special Examination (100 Marks) have to forfeit the marks scored in the Continuous/Internal Assessment (30 Marks) (Once a student opts for Special Examination, such student shall be treated to be ineligible to appear for the Repeat Examinations for 70 Marks).

All the eligible students who opt for the facility for Special Examination (100 Marks), have to submit in writing stating he/she has agreed to forfeit the marks scored in the Continuous / Internal Assessment (30 Marks). Such students may not be permitted to change the option at any point of time later. If any student is unable to pass the course (s), despite appeared in the Special Examination, such student henceforth shall be permitted to appear only in the Special Examination for 100 Marks as and when notified by TNNLU.

Fee:

The eligible students to avail the facility to appear in the Special Examination for 100 Marks are instructed to submit the filled in application along with fee payment of Rs.1000/- per course through UCO Bank Challan of TNNLS Branch or a proof of the online-payment transaction to the Examination Section on or before 31st October 2020, before 5 p.m. The Special Examinations for 100 Marks will be conducted during November / December 2020. The detailed schedule of the Examination and the Mode of Examination will be intimated later.

- 1. This facility is purely optional.
- **2.** Examination fees once paid will not be refunded under any circumstances or adjusted for future examinations.
