NOTIFICATION

It is hereby informed that the Tamil Nadu National Law University, has furnished the seat matrix to the CLAT Consortium for Admission into the UG and PG Degree courses for 120 seats and 18 seats respectively. Out of 57 seats under T.N quota for UG Degree [BA. LL.B.(Hons) & B.Com. LL.B. (Hons)], 11 seats were reserved for MBC/DNC category. Out of 9 seats under T.N quota for PG Degree, 2 seats were reserved for MBC/DNC category. Now, the Government of Tamil Nadu, in G.O(Ms) No75, dated 26.07.2021 has passed orders to give special reservation with effect from 26.02.2021 by splitting the MBC category as follows:-

1.	Most Backward Classes (Vanniakula Kshatriya)-MBC (V)	10.5
2.	Most Backward Classes & Denotified Communities - MBC&DNC	7
3.	Most Backward Classes	2.5

Hence, the 11 seats erstwhile reserved under MBC/DNC category for UG admission, has been restructured as follows:-

Further, the 2 seats erstwhile reserved under MBC/DNC category for PG admission, has been restructured as follows:-

It is informed that the application for CLAT exam was issued on 1st of Jan 2021 and the exam was also held on 23rd of July 2021 and now the results were also declared by the CLAT Consortium on 28.07.2021. At this juncture, the CLAT Consortium has informed that seats under two new categories i.e., MBC (V) and MBC could not be captured since the customized software for CLAT 2021 Central counselling has already been developed. As per the advice of the CLAT office the 2 new categories and the corresponding seats were dropped from the CLAT 2021 Central Counselling and the revised seat matrix including only the corresponding number of seats for the MBC/DNC category for UG and PG programmes were sent for the CLAT 2021 Central Counselling, as given below:

In this situation, the authorities of TNNLU have decided to fill the seats under the MBC (V) and MBC through direct admission by inviting applications from the candidates belonging to the respective categories. (all applicants should have taken the CLAT 2021).The seats to be filled by TNNLU directly in this category are as follows:

*One seat may be given by rotation to SC(A) / BC(M) / MBC / ST of Tamil Nadu, based on the roster in every admission.

It is also informed that except MBC (V) and MBC categories, all other reserved categories and general category under both T.N quota and A.I quota shall be filled through CLAT 2021 Central Counselling.

It is also informed that the candidates who belong to MBC (V) and MBC category and willing to apply for direct admission to TNNLU, are advised to participate in the CLAT 2021 Central Counselling if invited for it, as they are eligible for admission under both T.N and A.I General category.

It is also informed that this Notification is issued subject to the outcome of the Writ Petitions pending before the Hon'ble High Court of Madras, challenging the provisions of the Government Order in G.O(Ms) No75, dated 26.07.2021.
