INSTRUCTIONS TO THE CANDIDATES ADMITTED TO THE U.G. PROGRAMMES UNDER NRI/OCI QUOTA

The provisional admissions under NRI/OCI to B.A. LL.B.(Hons.) and B.Com. LL.B.(Hons.) programme will be finalised on 18.07.2022. Therefore, the Candidates who have been shortlisted under NRI/OCI quota to TNNLU for the academic year 2022-2023 are directed to submit the Google form with fees paid details which is available in the TNNLU website for formal admission. The Google form is available in the TNNLU website from 13.07.2022.
