**Admission to B.A. LL.B.(Hons.) & B.Com. LL.B.(Hons.) Degree Programme  
for the Academic Year 2023-2024 under**

**Non-Resident Indians (NRI) /  
Overseas Citizens of India (OCI) Quota**

(In connection with the admission notification issued by Consortium of National Law University dated 08.08.2022 for CLAT 2023 examination)

1. Applications are invited from eligible candidates for admission to B.A. LL.B. (Hons.) & B.Com. LL.B. (Hons.) Degree Programme offered by the Tamil Nadu National Law University (TNNLU), Tiruchirappalli-620027 for the academic year 2023-2024, under Non-Resident Indian (NRI) Quota/Overseas Citizens of India (OCI).

### 2. TOTAL NUMBER OF SEATS:

### 3. ELIGIBILITY CRITERIA:

- The candidates seeking admission under NRI/OCI quota should have secured not less than 60% mark in the aggregate in the qualifying examination.
- Candidates seeking admission under NRI/OCI Quota should appear for the **COMMON LAW ADMISSION TEST (CLAT) - 2023**. For details refer to <https://consortiumofnlus.ac.in/>
- Admission to the NRI/OCI quota will be made as per merit on the basis of marks secured by the candidates in the CLAT – 2023 examination.

#### 4. CATEGORIES:

**Two different categories of applicants will be considered for admission under NRI/OCI Quota as indicated below:**

<b>Category-I:</b> NRI/OCI parent	The Parent (Father or Mother) of candidates seeking admission should be an NRI/OCI.
<b>Category-II:</b> NRI/OCI Guardian	If the candidate has no parent where he/she has been taken as a ward by a near relative or someone and such NRI/OCI guardian has been legally declared as the guardian of the candidate by the Court as per the provision of Guardians and Wards Act, 1890.

**NOTE:** In each and every category, candidates will be selected based only on inter-se merit based on marks obtained in the CLAT-2023 examination.

#### 5. DOCUMENTS TO BE FURNISHED:

Candidates applying under NRI/OCI quota must furnish the **attested photocopies of the following documents along with the filled-in application:**

- a. NRI/OCI status certificate issued by the Indian Embassy of the respective country with seal.
- b. A certified true copy of OCI card in case of OCI category.
- c. Copy of the NRE (Non-Resident External) or NRO (Non-Resident Ordinary) Bank account passbook of the NRI/OCI.
- d. Copy of the valid Passport of the NRI/OCI. (OCI card issued by competent authority).
- e. Copy of the Birth Certificate along with the name of the NRI/OCI Parent issued by the competent authority (if applied under Category I).
- f. Certificate of relationship [between the NRI/OCI (Guardian) and the candidate] issued by the competent authority (if applied under Category II).
- g. Employment Certificate of the NRI/OCI. [In case of Self-Employment, nature of the business, annual income and required proof of Income-Tax payment (for the last 3 years)]
- h. Qualifying mark / Grade list of the candidate
- i. Certificate showing that the candidate has proficiency in the English language.

- j. School / College Transfer Certificate or Migration Certificate and Character Certificate (wherever necessary).
- k. CLAT 2023- Score Card
- l. Conduct Certificate issued on completion of Class XII Course
- m. Medical Fitness Certificate [recently obtained from a Government Medical Officer]

If the candidate fails to furnish any of the above documents, TNNLU reserve the right to reject the application. The candidates who are provisionally selected under NRI/OCI quota will be admitted only after verification of all original documents. They should surrender all the original certificates at the time of admission for verification.

On the date of admission, if any candidate fails to produce all the original certificates referred above then he/she will not be considered for admission and provisional admission granted will be withdrawn. Extension of time will not be given for producing the original certificates. On verification, if any discrepancy is noticed between information furnished in the application form and original documents produced, the selection will be cancelled. The University reserves the right to cancel the admission of any candidate for valid reasons.

**Note:** 1. In addition to the above fees (payable in US dollars), candidates selected under NRI/OCI should pay other fee and user charges in equivalent US dollars as prescribed for other candidates in Indian Rupees.

2. The fees/charges are subject to revision as per the decision of the University Authorities.

## 7. MODE OF OBTAINING APPLICATION AND SUBMISSION:

- i. Application for admission under NRI/OCI quota can be downloaded from the website of the Tamil Nadu National Law University ([www.tnnlu.ac.in](http://www.tnnlu.ac.in)). The cost of the application is US \$ 250/- only.

- ii. **The mode of payment of the application fee is as follows:**

Application fee in US dollar must be remitted to the following TNNLU bank account through ‘**SWIFT**’ or through ‘**Demand Draft**’.

- b. In case of payment through **Demand Draft** then it shall be drawn in favour of “**The Registrar, Tamil Nadu National Law University**”, payable at **Tiruchirappalli**.

- iii. **The mode of submission of application is as follows:**

- a. The filled-in application shall be submitted after the appearance of the candidate in CLAT 2023 and declaration of results thereto.
- b. The filled-in application along with relevant documents must be accompanied by a demand draft or proof of payment for the application fee.
- c. The filled-in application must be submitted in both hardcopy and softcopy.
- d. The hard copy shall be sent by post to reach Tamil Nadu National Law University, Navalurkuttapattu, Tiruchirappalli - 620027.
- e. The soft copy [i.e., **scanned copy** of duly filled in NRI/OCI application form with relevant documents and the demand draft or application fee payment receipt] shall be submitted through ‘google form’.
- f. The notification for last date to apply along with ‘google form’ will be uploaded on the website of Tamil Nadu National Law University ([www.tnnlu.ac.in](http://www.tnnlu.ac.in)) in due course.
