MODE OF OBTAINING APPLICATION AND SUBMISSION:

- i. The interested candidates for admission under NRI/OCI quota should fill the online application form through this link <https://forms.gle/eNnn58vywdefwN2o6>
- ii. The Google form link may also be accessed through the website of the Tamil Nadu National Law University (www.tnnlu.ac.in).
- iii. The cost of the application is **US \$ 250/- only**.
- iv. **The mode of payment of the application fee is as follows:**

Application fee in US dollar must be remitted to the following TNNLU bank account through '**SWIFT**' or through '**Demand Draft**'.

- b. In case of payment through **Demand Draft** then it shall be drawn in favour of **“The Registrar, Tamil Nadu National Law University”, payable at Tiruchirappalli.**

v. **The mode of submission of application is as follows:**

- a. The filled-in application shall be submitted only by the candidate who appeared in CLAT 2023 examination.
- b. The filled-in application along with relevant documents must be accompanied by a demand draft or proof of payment for the application fee.
- c. The filled-in application must be submitted in both hardcopy and softcopy. The soft copy shall be submitted through ‘google form’ along with scanned copies of relevant documents and the demand draft or application fee payment receipt.
- d. The last date to submit the google form is **31st March 2023 till 5.00 p.m.**
- e. For the submission of hardcopy, the filled-in application copy of Google Form (received as a submitted response through email) signed by the candidate and his/her NRI/OCI Parent or Guardian (as the case may be) at the last page along with the self-attested copies of relevant documents accompanied by a demand draft or proof of payment for the application fee shall be sent by post to reach The Registrar, The Tamil Nadu National Law University, Navalurkuttapattu, TNNLU (Sub-Post Off.), Tiruchirappalli – 620 027 on or before **9th April 2023.**
